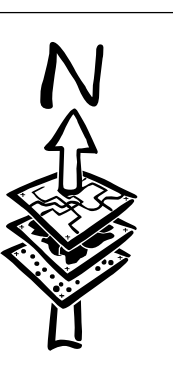
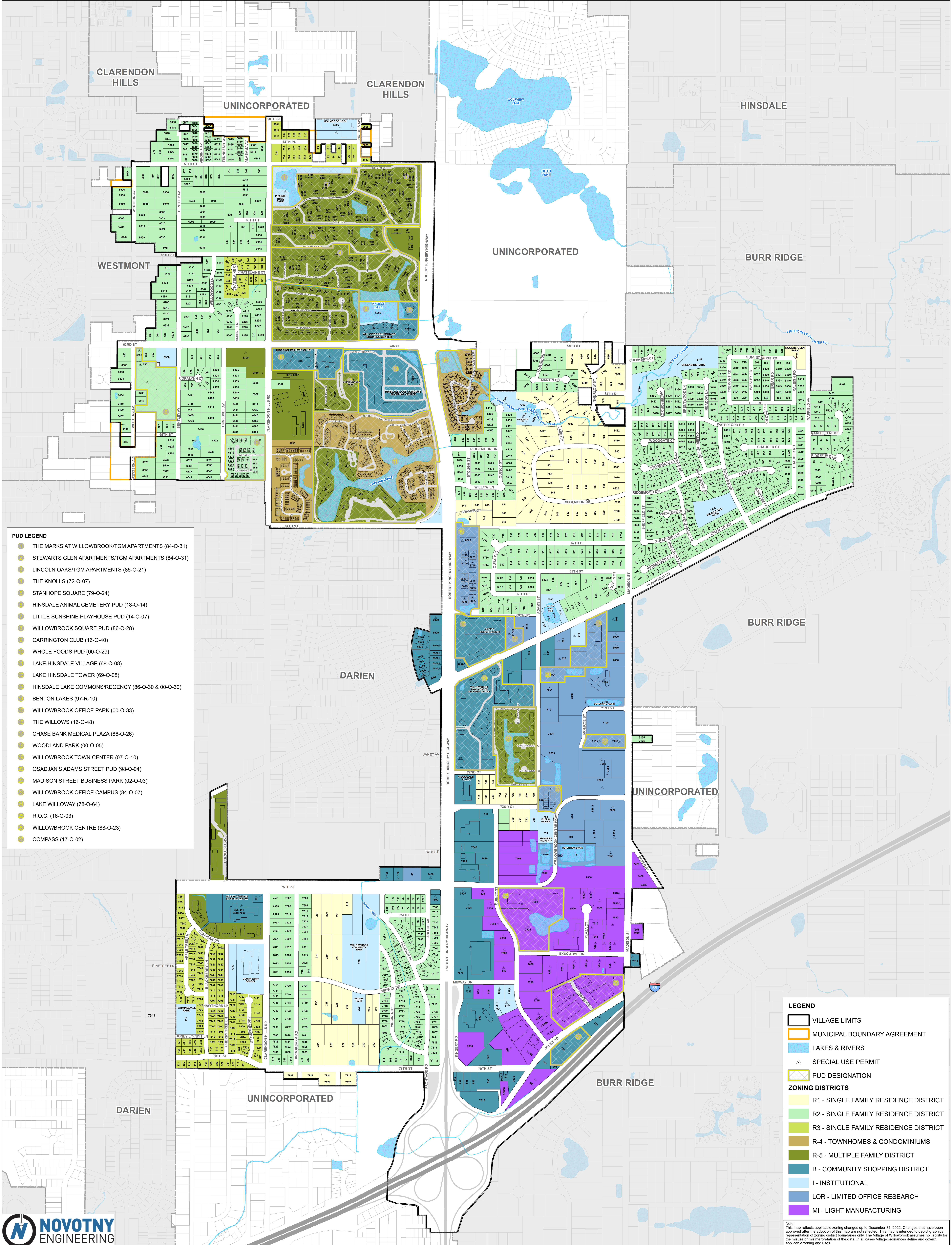




VILLAGE OF WILLOWBROOK 2023 ZONING MAP

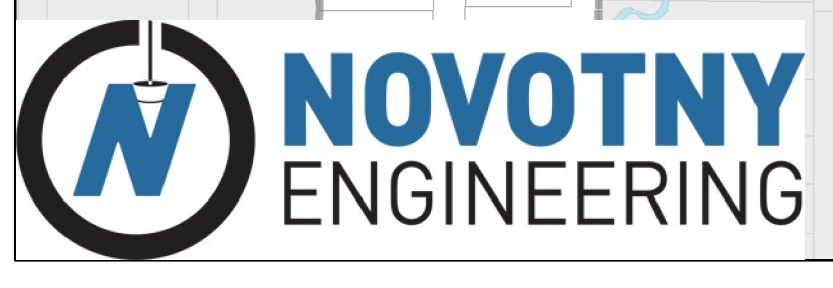
